- The Municipality of Mangatarem, Pangasinan now invites bids for the above Procurement Project. Completion of the Works is required 120 calendar days. The Municipality of Mangatarem, Pangasinan reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
