- 5. A complete set of Bidding Documents may be acquired by interested Bidders on May 8, 2023 from the given address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Hundred Pesos (Php 500.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees at the office given below.
- 6. The Municipality of Mangatarem, Pangasinan will not hold a Pre-Bid Conference for projects below One Million Pesos (Php 1,000,000.00).
- Bids must be duly received by the BAC Secretariat through manual submission at the Office of the Bids and Awards Committee, 3rd Floor Municipal Hall, Mangatarem, Pangasinan on or before May 31, 2023 at 12:00 PM. Late bids shall not be accepted.
