**Invitation to Bid for the
Construction of Cultural Center (Mangatarem District II) - Phase II at Mangatarem, Pangasinan
(2023-03-32)**

1. The Municipality of Mangatarem, Pangasinan, through the Local School Board Fund 2023 intends to apply the sum of Five Hundred Thousand Pesos (Php 500,000.00) for the Construction of Cultural Center (Mangatarem District II) - Phase II at Mangatarem, Pangasinan (2023-03-32) being the Approved Budget for the Contract (ABC) to payments for each lot. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Municipality of Mangatarem, Pangasinan now invites bids for the above Procurement Project. Completion of the Works is required 45 working days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from Municipality of Mangatarem, Pangasinan and inspect the Bidding Documents at the address given below from 8:00am – 5:00pm.
5. A complete set of Bidding Documents may be acquired by interested bidders on October 7, 2023 from given address and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Hundred Pesos (Php 500.00) for the said lot. The Procuring Entity shall allow the bidder to present its proof of payment for the fees at the office given below.
6. The Municipality of Mangatarem, Pangasinan will hold a Pre-Bid Conference¹ on October 17, 2023, 9:00 AM at the Bids and Awards Committee Office, 3rd Floor Municipal Hall, LGU-Mangatarem, Pangasinan which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before November 7, 2023, 10:30 AM. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 15.
9. Bid opening shall be on November 7, 2023, 10:30 AM at the Bids and Awards Committee Office, 3rd Floor Municipal Hall,, Mangatarem, Pangasinan. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The Municipality of Mangatarem, Pangasinan reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
