Invitation to Bid for the
**Construction of Foot Bridge at Brgy. Dorongan Valerio, Mangatarem, Pangasinan
(2024-03-08)**

1. The *Municipality of Mangatarem, Pangasinan*, through the **Supplemental Budget No. 2 2023 –(20% Development Fund)** intends to apply the sum of *Eight Hundred Thousand Pesos (Php 800,000.00)* for the **Construction of Foot Bridge at Brgy. Dorongan Valerio, Mangatarem, Pangasinan (2024-03-08)**, being the Approved Budget for the Contract (ABC) to payments for the said lot. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Municipality of Mangatarem, Pangasinan* now invites bids for the above Procurement Project. Completion of the Works is required **63 working days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from *Municipality of Mangatarem, Pangasinan* and inspect the Bidding Documents at the address given below from **8:00am – 5:00pm**.
5. A complete set of Bidding Documents may be acquired by interested bidders on **February 11, 2024** from given address *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of One Thousand Pesos (Php 1,000.00) for the said lot.* The Procuring Entity shall allow the bidder to present its proof of payment for the fees at the office given below.
6. The *Municipality of Mangatarem, Pangasinan* will hold a Pre-Bid Conference on **February 20, 2024; 9:30 AM** at the BAC Office, 3rd Floor of Municipal Hall, Mangatarem, Pangasinan which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before **March 5, 2024 at 10:30 AM**. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 15**.
9. Bid opening shall be on **March 5, 2024 at 10:30 AM** at the BAC Office, 3rd Floor of Municipal Hall, Mangatarem, Pangasinan. Bids will be opened in the presence of the bidders’ representatives who choose to attend the activity.
10. The *Municipality of Mangatarem, Pangasinan* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
