  at the BAC Office, 3<sup>rd</sup> Floor of Municipal Hall, Mangatarem, Pangasinan which shall be open to prospective
  bidders.
- Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before January 30, 2024 at 11:00 AM. Late bids shall not be accepted.
- All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB
  Clause 15.
- 9. Bid opening shall be on *January 30, 2024 at 11:00 AM* at the BAC Office, 3<sup>rd</sup> Floor of Municipal Hall, Mangatarem, Pangasinan. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The Municipality of Mangatarem, Pangasinan reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
